Services We Provide

- We are open Monday Friday from 6a to 4p and accept the following material:
- Clean concrete, dirty concrete and concrete with rebar
- Bricks, pavers, pre-cast concrete and millings, aggregate and stone
- Yard waste along with landscape materials and pallets
- Cardboard, (OCC), paper (SOP), Plastics and Aluminum
- Scrap metal All types
- Poles, framing and roof tiles
- Fill dirt

Construction & Demolition

- We currently receive material from throughout Broward County
- It comes from our own Hauling Division as well as from our competitors and local customers.
- The material is first separated inside out TS by type (different material in different areas on the floor. What can be recovered is removed and sold on the Open Market. No-recoverable material is currently taken to Titan in Medley. (Diverted from area landfills)
- All other non-recovered material is sent for diposal

Commercial Recycling

- We currently receive material from throughout Broward County
- It comes from our own Hauling Division as well as from our competitors and local customers.
- All material is separated. We are predominantly OCC, SOP and mixed plastic.
- It is baled and sold on the open market. I currently work with our Corporate Office on location, pricing and transportation; however I have other contacts/sites if they can provide a higher rate.

Barriers and Head Winds

- Enviro's primary barrier is our size. We are definitely interested; however, we are limited in volume that we can accept and process.
- On the call it was mentioned that SWA BC may consider awarding the bid to multiple sites.
- This is the niche that Enviro can fill We are centrally located and directly off 95 and close to 595 and the turnpike.
- If there's an opportunity to split the bid by tonnage or geographically, we can provide services.

Yard Waste

 With a 15 yr contract, Envirocycle would seek to upgrade our infrastructure to accommodate the grinding and processing

Policies or System Features

- Would the SWA negotiate rates or would they still be done through the ILA? – A known rate would allow each bidder to provide their best price as opposed to each City or Town negotiating their own directly with the site
- A common reporting format- set by SWA for transparency defining what is recycle vs recovered material. Also, flyers and/or material to be presented to residents and community groups.
- This will help in reducing contamination at the source

- Negotiation of rates for all municipalities and adoption of common rules/regulations for each to follow
- Material definition
- CPI based on water/sewer/trash index
- Act as a "clearing house for information that each site would provide to customers
