

City of Weston Announcement from Vice Mayor Henry Mead

Subject: Supporting C&D Recycling to Reduce Landfill Waste and Build a More Sustainable Broward County

The City of Weston is an active member of the Broward County Solid Waste Authority (BCSWA) and is working collaboratively with all 28 participating municipalities to address the County's growing solid waste and recycling challenges.

One of the largest opportunities for progress lies in the construction and demolition (C&D) sector, which represents the single largest component of Broward County's overall waste stream—approximately 36% of all solid waste generated. C&D materials, including concrete, wood, metal, asphalt, and roofing debris, are heavy, bulky, and occupy substantial landfill space. Yet, these same materials hold significant potential for recovery and reuse.

Across Florida, several counties have demonstrated what's possible. Lee County, for example, has achieved a 97% C&D recycling rate through its local ordinance and partnership with licensed recyclers. By contrast, Broward County currently recycles less than half of its C&D materials, according to the Florida Department of Environmental Protection's most recent report.

Broward County already has a strong network of licensed and permitted C&D recycling facilities; many located within short haul distances of active construction areas. These facilities can separate and process C&D debris into reusable components for new construction, road base, or landscaping material.

As a proactive step—before any formal countywide policy action, the City of Weston and the Broward County Solid Waste Authority are urging all contractors, builders, and haulers to utilize one of the ten Florida Department of Environmental Protection (FDEP)-permitted C&D recycling facilities listed on the attached page. Directing your materials to these facilities instead of landfills will help divert up to 900,000 tons of recoverable material annually and preserve valuable landfill capacity for non-recyclable waste.

Your cooperation is essential in building a cleaner, more resilient, and sustainable Broward County.
