


Commercial

Over **61%** of Broward County's commercial waste stream is recyclable or compostable.





Regulatory Framework for Commercial Recycling Programs



Florida jurisdictions demonstrate multiple viable regulatory models for commercial recycling.

Graduated compliance model
Small generator exemptions
Stream-based recycling requirements

City of Orlando

Infrastructure-first approach
Access and availability model
Tenant-focused implementation

City of Gainesville / Alachua County

Tiered requirements
Organics-focused diversion
Sector-based obligations

Collier County & City of Hollywood

Education-first implementation
Single-stream commercial recycling
Interlocal coordination model

Miami-Dade

Durable program with high compliance

Comprehensive Coverage

- Designated materials: Paper, cardboard, plastic, metals, glass

Clear Performance Standards

- Material separation requirements
- Recordkeeping and compliance

Enforcement Framework

- Escalating fines: \$300 → \$950
- Repeat violation structure

Implementation Support

- Education & guidance materials
- Business compliance assistance

Exemption for small generators, hardship, or alternative compliance (e.g., on-site processing, donation, reuse)

Generator or Owner transports Recyclable Materials directly to a Recycling Facility (e.g., requiring receipts or weight tickets).



- **Q2–Q3 2026:** Adoption & Implementation
- **Q2–Q4 2026:** Education & Outreach
- **Q1–Q2 2027:** Voluntary Compliance
- **Q3–Q4 2027:** Full Enforcement
